### NOTES:

1. This brochure sets out the dates, costs and geographical locations of our public courses in data protection and freedom of information. **PART 1 (pages 3 to 5)** deals with **data protection** and **PART 2 (pages 6 to 8)** deals with **freedom of information (FOI)**.
2. Course booking facilities, full details of course content, and precise location of course venues can be accessed from the Amberhawk web-site, [www.amberhawk.com](http://www.amberhawk.com) or from [info@amberhawk.com](mailto:info@amberhawk.com) (or telephone: 0845 680 2623). The site offers both an automated booking system and a booking form that can be completed offline.
3. Each day of a course has a course code (e.g. **D1**) and a course title (e.g.). "**Introduction to data protection**" These codes and titles are fully described in our course brochures and it may be convenient to have the relevant course brochures to hand when looking at this brochure.
4. Courses **D1-D7** and **F1-F7** each cover specific subject matters that those responsible for Data Protection or FOI need to know. These courses can be booked in any combination to cover your particular training requirements. If you are not sure what you need, we have provided a table in the relevant course brochure to help you choose the right courses.
5. **The following two bullets are important for ISEB delegates:**
  - Attendance at **all** courses **D1-D7** or **DN1-DN5** covers the ISEB syllabus in data protection; similarly attendance at **all** **F1-F7** or **FN1-FN5** covers the ISEB syllabus in FOI (our combination course **Q1, Q2, V1** or **V2** is a shorthand for the day courses that cover the relevant ISEB syllabus in DP or FOI). You **also** need to book the relevant the exam package **QE** (Data Protection) or **VE** (FOI), as this prepares delegates for the exam.
  - Courses **DN1-DN5** and **FN1-FN5** are intensive courses. They may not suitable for those new to the subject and who are seeking the ISEB qualification. Please look at the FAQs which describe the difference in the teaching approach we adopt in both the long and the intensive courses.
6. We offer discounts on multiple bookings and for members of the **Data Protection Forum** or **NADPO**; the automated booking system takes account of these. Charities, Housing associations and hospices etc booking an ISEB course should be aware of the **Shelagh Gaskill Bursary** which provides for up to £1000 discount (details on web-site)

## DISCOUNTS

### Discounts for multiple course bookings in data protection

The amount of discount depends on the number of full delegate days of training booked.
